☐ University Transcript(s)

Please do not apply if your GPA falls below the acceptable minimum.

- Minimum “B” GPA: approximately 3.0 (out of 4.0 scale), 3.5 (out of 5.0), 80% (out of 100%)
- **FOR INTERNATIONAL APPLICANTS:** Academic transcripts reflecting the equivalent of a “B” or “Very Good” – meet this criteria. If possible, please provide an official letter from the university, assigning your GPA to a 4.0 scale conversion.
- **UNOFFICIAL COPIES OF TRANSCRIPTS ARE FINE FOR REVIEW.** Official transcripts will be needed if admitted to the program.

☐ Three (3) Letters of Recommendation

REMINDER: All three letters of recommendation *must come directly from the recommenders themselves via e-mail* to hsinternational@ucsd.edu in order to be considered valid for your application.

Please ask your reference to include the following details in his/her letter:

- Relationship to applicant (supervisor, professor, etc.)
 - Duration of relationship (6-months, etc.)
 - Assessment of applicant’s personal and professional character
 - Evaluation of skills, accomplishments, strengths, and qualifications
- ✓ Do **NOT** provide more than the required 3 letters of recommendation. Only the first three letters received will be considered during the evaluation of your application.
 - ✓ At least one academic reference AND at least one professional reference required
 - ✓ Reference our **CORE Program Letter of Recommendation Guidelines** for more information

☐ Letter of Intent

This letter is geared towards a separate admissions committee and should not be the same personal statement used in the MAS application. This second committee will be evaluating your fit into the CORE Program and your future training and career goals. Please provide the following details in your letter (1-page typed, double spaced):

- Clinical research interests and professional goals
- Anticipated Benefits of CORE toward your career goals
- Personal strengths
- Preferred clinical specialty area

☐ Financial Sponsorship Letter

Please note that your financial sponsorship letter should include mention of the Clinical Observership & Research Education (CORE) Program at UCSD. **This letter must:**

- Provide a guarantee for tuition and any associated living expenses, including health insurance
- Be an official document on the organization's letterhead, with valid date, signature and contact information of the funding authority.
- Funding Authority must indicate effective start/end dates of financial coverage within the CORE Program at UC San Diego, specifically
- E-mail a copy of this letter to hsinternational@ucsd.edu as soon as received.

Other Required Criteria

☐ Test of English as a Foreign Language (TOEFL) Exam

REQUIREMENT IS FOR INTERNATIONAL APPLICANTS ONLY

- TOEFL scores should be sent directly from ETS, electronically to UCSD
- UC San Diego's Institution Code is: **4836**
- If requested, the Department Code for MAS Programs is: **99**
- The TOEFL **must** have been taken within the **last two years**
- Please note that *UCSD only accepts electronic "internet-based" (iBT) TOEFL scores* (paper-and-pencil, as well as computer-based test scores are **not** accepted)
- UCSD's minimum TOEFL score required for admissions consideration is **80** for the internet-based test (**iBT**).



☐ Phone Interview with UCSD Health Sciences International

A phone interview is required and will be done by invitation only. Due to high volume of competitive applicants, we do not offer phone interviews to everyone. Phone interviews will be conducted by a UCSD HSI Program Representative and typically take place 2-3 weeks after the application deadline.

Each applicant will be assessed on the following criteria:

- Conversational proficiency in the English language
- Ability to clearly describe CORE program and overall career goals
- Ability to clearly define research interests
- Demonstrated ability to work in teams and/or as a leader

Letter of Recommendation Guidelines

A good letter of recommendation should provide an accurate assessment of the applicant's suitability for a master's degree program. It is best to have letters from individuals who know you well and can assess you in more detail and should contain the following elements:

- Briefly explain your relationship with the applicant: How long you have known the applicant
- In what capacity you have interacted (e.g., faculty, pre-medical advisor, supervisor, etc)
- Focus on behaviors that you have observed directly when describing applicants' suitability for clinical research. Consider describing: The situation or context of the behavior

Admissions committees find comparison information helpful. If you make comparisons, be sure to provide context. Include information about: the comparison group (e.g., students in a class you taught, students in your department, co-workers, etc.) and your rationale for the final comparison

It is also helpful if the letter can address other competencies such as

- **Critical Thinking Skills:** the use logic and reasoning to identify the strengths and weaknesses of alternative solutions, conclusions, or approaches to problems
- **Quantitative Reasoning:** Applies quantitative reasoning and appropriate mathematics to describe or explain phenomena in the natural world
- **Scientific Inquiry:** Applies knowledge of the scientific process to integrate and synthesize information, solve problems and formulate research questions and hypotheses; is facile in the language of the sciences and uses it to participate in the discourse of science and explain how scientific knowledge is discovered and validated
- **Ethical Responsibility:** Behaves in an honest and ethical manner; cultivates personal and academic integrity; adheres to ethical principles and follows rules and procedures; resists peer pressure to engage in unethical behavior and encourages others to behave in honest and ethical ways; and develops and demonstrates ethical and moral reasoning
- **Reliability and Dependability:** Consistently fulfills obligations in a timely and satisfactory manner; takes responsibility for personal actions and performance
- **Capacity for Improvement:** Sets goals for continuous improvement and for learning new concepts and skills; engages in reflective practice for improvement; solicits and responds appropriately to feedback

Key Reminders

- ✓ Ensure the letter is prepared on the Organization's Official Letterhead
- ✓ Request that your recommendation letter be at least 500 words in length (typed & double-spaced)
- ✓ Including Title/Position/Credentials of Recommender; as well as date & signature
- ✓ Must address applicant's academic/professional traits as an individual and clinical research scholar

Sample Recommendation Letter # 1

Dear Admissions Committee:

Sample Recommendation Letter # 2
